

1. CALL TO ORDER

Meeting is called to order at 18h52.

We would like to begin by acknowledging that Concordia University is located on unceded Indigenous lands. The Kanien'kehá:ka(Ga-niyen-gé-haa-ga) Nation is recognized as the custodians of the lands and waters on which we gather today. Tiohtiá:ke(jo-jya-gé)/Montreal is historically known as a gathering place for many First Nations. Today, it is home to a diverse population of Indigenous and other peoples. We respect the continued connections with the past, present, and future in our ongoing relationships with Indigenous and other peoples within the Montreal community.

3. CHIEF ELECTORAL OFFICER

Samantha Candido: This meeting was called to address things going on with Chief Electoral Officer's. performance. The job is not necessarily in a state of jeopardy, just a request that that the people delegated with the task keep members accountable by launching a protocol for the next steps. The CEO is currently running many different elections (LSSA, SASU, PSSA, possibly SHAC) and the CSU by-elections. There is also a lag in posts from the Communications team with respect to call-outs and a use of Spotted Concordia to post about elections.



Margot Berner: I know people running for councillor positions and they did not receive notice that their applications were accepted when they were supposed to be campaigning which puts them at a serious disadvantage. I do not think the CEO does not have sound judgment but they have a lot on their plate doing multiple elections and I want to put on table that perhaps having them do big elections is not the greatest idea. There were also problems with them putting up unprofessional posters that were handwritten. We need to expect more.

Peter Zhuang: The CEO was appointed really late which caused everything to be delayed. As for conflict of interest, there is no rule specifically saying in bylaws that they cannot do other things.

Sophie Beauchamp-Lizotte: The use of Spotted Concordia is a big deal as it is not a platform accessible to all and the people in charge of it can choose what they want to post. Acknowledges that the CEO was hired late so this was extenuating circumstances but when running five (5) elections at once they cannot do a proper job while being student.


Motion carries.
